ICCTA BOARD HIGHLIGHTS

May 2, 2013

The ICCTA Board of Representatives took the following actions at its April 30, 2013, meeting at the President Abraham Lincoln Hotel in Springfield, Illinois:

- Previewed ICCTA's May 1 Lobby Day, which included a morning briefing with Illinois Board of Higher Education executive director Dr. Harry Berman. Trustees are focusing on budget issues when talking with legislators this year;
- Learned that community colleges have been asked to return \$400,000 in Monetary Award Program grant funds due to a miscalculation by the Illinois Student Assistance Commission. The Illinois Community College Board may pursue a legislative remedy to offset this shortfall;
- Adopted the ICCTA Finance Committee's proposed FY 2014 budget, which includes a 2% dues increase
 previously approved by the ICCTA Board of Representatives;
- Received the ICCTA Nominating Committee's proposed slate of officers for 2013-2014:
 - * William Kelley (Harper) Vice president
 - * Andrew Bollman (Sauk Valley) Secretary
 - * Dr. Nancy Svoboda (DuPage) Treasurer

Officers will be elected at the June 8 annual meeting in Chicago. Current vice president Bob Johnson (Kishwaukee) will assume the presidency on July 1.

- Were informed that the search for ICCB's new executive director has been narrowed to three finalists. The state board is anticipated to announce its selection at its June 7 meeting in Chicago;
- Heard that the Illinois Presidents Council has adopted the following slate of officers for 2013-2014:
 - * Dr. Christine Sobek (Waubonsee) President
 - * Dr. Tom Choice (Kishwaukee) Vice president
 Dr. Charlotte Warren (Lincoln Land) Secretary/treasurer
- Learned that the ICCTA Executive Committee approved several service awards, which will be presented during the association's June 7-8 convention in Chicago;
- Were informed that ICCTA staff is researching the feasibility of creating a trustee certification program;
- Received updates and reports from ICCB, ISAC, IBHE, and the Association of Community College Trustees; and
- Congratulated the 44 new trustees who were elected (and the incumbents who were re-elected) to their local boards in the April 9 non-partisan election.
