The ICCTA Board of Representatives took the following actions at its June 6, 2015, annual meeting at the Renaissance Schaumburg Hotel and Conference Center in Schaumburg, Illinois:

- Learned that the Illinois General Assembly has gone into extended session. Creating the state's <u>Fiscal Year 2016</u> <u>budget</u> will remain the top priority of lawmakers this summer;
- Received updates on <u>FY 15 budget cuts</u>, pension reform, <u>procurement mandates</u>, <u>limits on executive compensation</u>, attempts to limit local control, GED testing changes, Illinois Veterans Grants, and the Workforce Innovation and Opportunity Act;
