ICCTA BOARD HIGHLIGHTS

May 6, 2011

The ICCTA Board of Representatives took the following actions at its May 3, 2011, meeting at the President Abraham Lincoln Hotel in Springfield, Illinois:

- Previewed ICCTA's May 4 Lobby Day (see enclosed Fact Sheets). Trustees will ask their state legislators to:
 - 1) SUPPORT Gov. Quinn's Fiscal Year 2012 community college budget
 - 2) SUPPORT increased funding for Monetary Award Scholarships
 - 3) DEVELOP performance-based funding measures that accurately assess community college outcomes
- Distributed ICCTA's "65/13" stickers, which illustrate that community colleges serve 65% of the students in Illinois higher education but receive only 13% of the state funding;
- Were informed that the Illinois Community College Board is creating a statewide task force to review the system's funding formula;
- Heard a report on the April 2011 trustee elections. A total of 97 trustee seats were up for election; 44 new trustees won election; and 15 incumbents were not re-elected;
- Adopted the ICCTA Finance Committee's proposed FY 2012 budget, which includes no dues increase;
- Received the ICCTA Nominating Committee's proposed slate of officers for 2011-2012:
 - * Reggie Coleman (John Wood) Vice president
 - * Nancy Svoboda (DuPage) Secretary
 - * Bob Johnson (Kishwaukee) Treasurer

Officers will be elected at the June 4 annual meeting in Normal. ICCTA's current vice president James L. Ayers (Parkland) will assume the presidency on July 1.

- · Approved the ICCTA Bylaws Committee's proposed revisions in the association's Operating Rules;
- Learned the ICCTA Executive Committee extended the contract of executive director Mike Monaghan through 2014;
- Were updated on ICCTA's June 2-4 annual convention in Normal, which will feature a seminar on statewide branding, a New Trustees Orientation, an awards luncheon, the ICCTA President's Reception, and the annual awards banquet;
- Heard that the Illinois Presidents Council will be sponsoring legislative seminars this summer at five locations around the state:
- Invited trustees to attend two events in conjunction with ICCTA's May 4 Lobby Day: the re-dedication of the Harry
 L. Crisp II Community College Center and a reception sponsored by the City Colleges of Chicago;
- · Thanked Spoon River College for hosting ICCTA's annual Administrative Professionals Conference; and
- Learned that the Illinois Presidents Council elected the following officers for 2011-2012:
 - * Dr. Gayle Saunders (Richland) president
 - * Dr. Margaret Lee (Oakton) vice president
 - * Dr. Christine Sobek (Waubonsee) secretary/treasurer
