The ICCTA Board of Representatives took the following actions at its November 9, 2013 meeting at the Hyatt Regency Hotel in Schaumburg, Illinois:

- P Received updates on pension reform, the College Insurance Program for community college retirees, concealed carry, implementation of 'return to work' restrictions, and extension of the temporary income tax increase;
- P Were asked to provide anecdotal information to ICCTA about 'overachieving students' in dual credit programs. The information will be shared as part of ICCTA's testimony at Illinois Senate Higher Education Committee hearings this fall:
- P Learned that ICCTA's November 8 Legal and Legislative Update received high marks. The seminar featured sessions on the Affordable Care Act, the Open Meetings Act, the Freedom of Information Act, and the State Officials and Employees Ethics Act;

- P Heard that Barbara Oilschlager (Lake County) will serve as ACCT's state coordinator for Illinois, succeeding Diane Gallagher;
- P Learned that participants in ICCTA's Trustee Roundtable and Fireside Chat discussed board/foundation relations and trustee professional development;
- P Expressed get-well wishes to ICCTA past president Reggie Coleman (John Wood);
- P Were updated on the ICCTA PR Committee's "Reel Illinois" student film competition;
- P Received notice of the resignations of trustees Thomas Gary (Triton) and Mary Tuite (Rock Valley). Jody Wadhwa (Oakton) will assume Tuite's role as vice chair of the ICCTA Diversity Committee;
